East Asian Studies Librarians: Moving Beyond (Job) Boundaries

For decades, the “public services” / “technical services” divide has defined CEAL members’ professional lives and their job duties tended to cluster under traditional rubrics, such as collection development, reference and instruction, and cataloging. As academic libraries evolve, East Asian studies librarians are taking on a variety of new roles, which often require new knowledge and skills. Areas to be explored include: web archiving, micro-blog harvesting, archival processing, consortial licensing, linked data creation, collecting digital video content, and digital humanities.

Conflict of Interest and the East Asian Studies Librarian: Employer in “the west” / Vendor in “the east”

Most East Asian studies librarians are employed by academic institutions with written codes of conduct and expectations for ethical behavior in business dealings. Nevertheless, conflict of interest situations are often ambiguous and require case-by-case decision-making. The difficulties are compounded when dealing with a part of the world in which cultural norms encourage gift-giving and a high level of hospitality for visitors. This panel will explore two questions:

- Does the “western employer” / “eastern business partner” distinction imply differing approaches to ethical behavior?
- How can CEAL librarians successfully meet employer expectations for ethical conduct, especially while doing business with vendors based in East Asia?
