## Japanese Materials Committee Chair 2011-2014

### Hiroyuki Nagahashi Good

(University of Pittsburgh)



I have been working at the University of Pittsburgh as Japanese Cataloger/Interim Japanese Bibliographer from 2004 to 2005 and as Japanese Bibliographer since 2006. My library experience includes, but is not limited to: cataloging, reference and instruction services, collection development and management, information literacy education, online database licensing, and grant writing. I received my MLIS from the University of California, Los Angeles in 2004; I earned my MA in Asian and American Studies from the California State University, Long Beach in 1994. Before launching my library career, I worked as a PR manager for the Japanese American National Museum, as a TV producer for a local Japanese TV production in California, and a businessman for a Japan-China trading company in Tokyo and Beijing.

Currently, my interest centers on the rapid development of formats and distribution channels of Japanese eBooks in recent years. During my last research trip to Japan last November, I learned that Japanese publishers and information specialists finally came to a realization of the increasing importance of eBooks thanks to the Google book settlement and the explosive sale of iPad. The National Diet Library (NDL) received \$865 million from Japanese government for the digitizing project last year and has digitized 930,000 volumes of books so far. Next three years will be the most crucial period for Japanese eBooks and we have to keep up with their changes in order to provide the most updated and useful information to Japanese studies communities in North America. If elected, I believe we should explore the expansion of certain initiatives, such as

- networking with Japanese librarians and information specialists to discuss issues on accessing and dissemination of Japanese academic information
- Contacting vendors and researchers to discuss issues on copyrights, user evaluations and usage analysis of Japanese databases and eBooks
- networking among librarians, information specialists and researchers in Japanese Studies across the globe to discuss academic librarianship and collection development in all formats

### Setsuko Noguchi

(University of Illinois at Urbana-Champaign)



Setsuko Noguchi is a Japanese Studies Librarian for CIC (Committee on Institutional Cooperation) and serves as the librarian for Japanese Collections at University of Illinois at Urbana-Champaign, University of Wisconsin at Madison, and University of Minnesota at Minneapolis. She earned her BA in Japanese Literature and her MS in Library and Information Science. She has served as an OCLC CJK Users Group Japanese officer and as a member of several CEAL committees



(Committee on Public Services, Committee on Technical Processing, and Committee on Japanese materials). She has also served on the NCC Digital Resource Committee and co-chaired the NCC Librarian

Development Committee. She also chairs a discussion group of CIC+Midwest Japanese collections.

We have been entering in a new library era that is transforming our environment significantly. Our job is affected by economic strain and fast-paced change in information technology. If I were elected, I would contribute to work with issues by exploring and sharing several perspectives such as possible new strategies of collection development, evaluation, resource sharing, and outreach opportunities with my colleagues. For example, I would like to look into methods of collection development, service extension to undergraduate students, and collaborative work with faculty.

Furthermore I would like to develop more connections with librarians and staff globally. Broadening our network, especially among those who deal with small to medium sized Japanese collections both in the North America, Europe, and Japan will be valuable benefit because it will enable us to share ideas, resources, and information in order to build our sustainability.
