The 2019 Annual Open Meeting of the North American Coordinating Council on Japanese Library Resources (NCC) will focus on various impacts resulting from the recent amendment of the copyright law in Japan. Most notably, the amendment will enable the National Diet Library to plan for the expansion of its online services to overseas libraries by granting overseas libraries access to digitized copyrighted contents at the same level as they are provided to Japanese libraries and under the same conditions. The amendment will also lengthen the copyright protection from 50 to 70 years after the death of the creator, as well as it will allow digitization for text-mining purposes (snippet views). Speakers on this panel will present in detail about the NDL online services, other anticipated services, and projected changes incurred by the amendment. They will also discuss potential projects and/or research topics now being considered at academic institutions in Japan based on other aspects of the amendment.
